SECTION 4) FIRST-AID MEASURES

Inhalation

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Ventilation Requirements
